

Church of the Lakes Lil' Lambs Closet Seller Agreement

In consideration for the opportunity to participate in and profit from LLC (Lil' Lambs Closet) Sales, the undersigned seller agrees to the following:

1. Seller agrees to hold harmless and make no claim against LLC, Church of the Lakes where the sale is held, any volunteer, or participants in the LLC or the insurer of LLC for the damage, theft or loss of any items consigned to LLC. LLC does not anticipate any thefts, damage, or loss and takes every precaution to prevent them but occasionally these events may occur.

2. Seller agrees to waive any and all claims against LLC, Church of the Lakes, any volunteer, or participants in LLC or the insurer of LLC.

3. Volunteers will be needed before, during, and after the sale. Once you are scheduled, we rely on you to keep your commitment to working your scheduled shift. IF for any reason you cancel or do not show for your work shift, after the posted deadline, you will be prohibited for the current sale and the following two sales. Work shifts are based on the amount of inventory listed in your account. You cannot base it on what you actually bring in or what you assume might be denied. All items should be prepared for sale. If there is any question about an item being denied, don't bring it. We certainly appreciate all those who offer their time. Thanks in advance! We know attending pre-shopping is worth the effort.

4. Seller agrees to follow the directions as outlined on the website closely and carefully for preparing items for sale. This includes, but is not limited to making sure all parts are in working order, clothing is free from stains, holes, broken or missing parts, clothing is hung properly on good size hangers, items requiring batteries include new, working batteries, large inflatable's must include a current phone number for a buyer to call if the item is not working or has a hole.

5. Seller agrees to follow the list of acceptable categories carefully. Acceptable items at the current sale are limited to the items listed on the category sheet. Items brought in that are not on the list will be denied. There will be no exceptions.

6. Seller agrees that items with no tag will not be sold, but will be placed in a lost and found area at the end of the sale. It will be the sellers' responsibility to check this area, along with their unsold items before leaving the building. LLC will make every attempt to reunite an item with its tag, but occasionally this is not possible.

7. Seller agrees that only one adult may enter under their consignor number for pre-shopping. Due to safety and fire codes, children are also prohibited from attending pre-shopping. Seller also agrees to pre-shop within their assigned time frame and understand they will be asked to complete their shopping prior to the ending time. This will allow the next set of shoppers to enter, or for volunteers to finish their shifts within the preset times.

8. Seller agrees to the use of cash or check only when paying for items during the pre-shopping hours. Credit card usage will not be available at pre-shopping.

9. All goods left in the possession of LLC are at the sole risk of the seller. Seller agrees that it shall assume and bear all risks regarding consigned goods, and will hold LLC exempt from any and all liability: to include but not limited to theft, fire, wind, or rain. LLC reserves the right to remove any items from the sale due to wear, poor condition, or stains. Items remaining after the posted pick up time will be donated.

10. Seller agrees to cash checks issued as proceeds from the sale no earlier than 5 business days after the sale and within 60 days (replacement checks will not be issued.)

11. Seller agrees to allow LLC to use any pictures or video taken during the week of the sale for future advertisement. LLC will not sell or disclose any information or media to any third party.

12. Seller agrees that no claims will be made against LLC for any discrepancies involving items placed in the sale.
